Selection Criteria for International House Residents

(Decided by the International Exchange Committee on May 30, 1988)

(Amended by the International Exchange Committee on May 6, 1992)

In order to contribute to the promotion of international exchange at the university, which is the purpose of the International House (hereinafter referred to as the "House"), the following measures were taken

- I. International Students
- 1. Occupancy Standards
- (1) Priority for selection of International House (hereinafter referred to as "the House") tenants shall be as follows, and details of each program are specified in the Appendix.
 - ① Short-term international students (special research students, special auditing students) under the Inter-University Exchange Agreement, Double Degree Program, and Graduate School Twinning Program.
 - ② Newly admitted international students who are not listed above.
 - ③ International students other than ① and ②.
- (2) The following persons will not be permitted to move in:
 - ① Those who have already been accepted by other accommodations on campus.
 - ② Those who have not applied to move in the House.
- (3) A person who has moved into a single room (or a couple's room) and wishes to move into a couple's room (or a family's room) may be permitted to do so within a total period of one year, as long as there are vacant rooms.

2. Method of deciding on a resident

(1) The Director shall decide on the residents, taking into consideration the number of available rooms for the relevant year and the circumstances of the applicants.

3. Period of Residence Permission

- (1) The approved period of residence is, in principle, one year or less, in accordance with Article 10 of the International House Regulations. However, for those who meet the criteria of Occupancy Standards I (1) ①, the period shall be the enrollment (acceptance) period approved by the program. In addition, for those who meet the criteria (1) ② and ③, a period of up to six months may be permitted. Furthermore, an extension of the period of stay may be granted by submitting an "Application for Extension of Period of Stay.
- (2) The period of stay for those who have moved from a single room to a family or a couple's room shall be up to a total of one year.

4. Others

In order to facilitate exchange with international students and to facilitate the operation of the House, students from the Toyohashi University of Technology be assigned as tutors.

II. Foreign Researchers

- (1) Applicants will be selected in the order in which they submit the application form to the International House.
- (2) The following persons will not be permitted to move in:
 - ① Those who are already living in private accommodations in Japan.
 - ② Those whose period of stay as a researcher exceeds one year, or is expected to exceed one year.
 - 3 Those who meet the conditions for moving into Toyohashi Municipal Housing.
- III. In cases where the operation of these standards is impractical, the Director shall decide.
